Specification – Please include:- <ul style="list-style-type: none"> • When? • How Often? • Planned/Responsive? • Maintenance schedule? • Renewal/replacement? • Other? 	<p>Northfield BID is covered by two neighbourhood teams within the Northfield constituency specifically the Northfield neighbourhood team and the Weoley Castle neighbourhood team.</p> <p>The teams work opposing shift patterns to maximise coverage to the town centre and surrounding roads with shifts comprising 3 early shifts between the hours of 07:00hrs and 15:00hrs and three late shift between 15:00hrs and midnight.</p> <p>To complement the service provided by the neighbourhood teams a response team based at Bournville Lane Police station is available to respond to emergency incidents on a 24/7 basis.</p> <p>The neighbourhood teams conduct regular patrols made up of both vehicular and foot patrols of</p>

	<p>Northfield town centre and also carry out focused activities within the BID area designed to drive down issues of Anti-Social Behaviour and criminality.</p> <p>The teams work with retailers in the town centre to identify issues of concern and work collaboratively to find solutions to these issues, one such example undertaken recently is the disruption work around a known group of street drinkers who have been banned from the town. More recently work is on-going to apply similar tactics to prolific shoplifters keeping them out of the town centre and protecting retailers from potential thefts</p>
